Our Christian roots are centered among people who were sojourners in the land. Through out his tory, peo ple have been up-rooted un der con di tions sim i lar to that of Mary and Jo seph, who were forced to flee to save the life of their son. Most of our own forefathers and foremothers were im mi grants to this country. The Bible is clear about how we should treat these wan der ers:

When stran gers so jour n with you in your land, you shall not do them wrong. The stran gers who so jour n with you shall be to you as the na tives among you, and you shall love them as your self; for you were stran gers in the land of Egypt. . . .

(Le vit i cus 19:33-34, Re vised Stan dard Ver sion)

Im mi grants come to the United States because communities throughout our world are suf fer ing from war, civil con flict, **eco nomic hard ships, en vi ron men tal de struc tion,** and per se cu tion for po lit i cal, re lig ious, eth nic, or so cial rea sons. **They come seeking food and shel ter—refuge—but in stead they are met with closed doors and de ten tion cen ters fu eled by at ti tudes of rac ism, xen o pho bia fear or hat red of fore ign ers and hos til ity. Im mi grants with or with out le gal sta tus are vul ner a ble to hu man rights ab uses start ing with coyotes peo ple who pro vide il le gal trans port a tion into the United States to the sub stan dard work ing con di tions and low wages that swell busi ness profits. Of ten im mi grants are forced into pros ti tu tion and other forms of il le gal work in or der to pay their trans por ta tion debt.** The World Coun cil of Churches re ports that two out of ev ery 100 hu man be ings are flee ing their coun try, and many fam i lies are forc ibly dis placed within their own coun tries. For these rea sons, we stand firmly op posed to **state or fed eral** legis la tive ac tion such as that pro posed in **the fed eral Il le gal Im mi gra tion Reform and Im mi grant Re spon sibil ity Act of 1996,** Cali for nia's Prop o sition 187 or any sim i lar legis la tion **which dis crim i nates against**

im mi grants and that may have the fol low ing ef fects:

— *Pub lic Schools:* Dis tricts are re quired to ver ify the le gal sta tus of stu dents en roll ing for the first time. The sta tus of par ents or guard ians of stu dents must also be ver ified;

— *High er Edu ca tion:* Un doc u mented im mi grants are barred from com mu nity col leges and pub lic in sti tu tions of higher learn ing;

— *Health:* Un doc u mented im mi grants **as well as le gal im mi grants** are in el i gible for pub lic health ser vices, ex cept for emer gency care;

— *Wel fare:* Un doc u mented im mi grants **as well as le gal im mi grants** are al ready in el i gible for the major wel fare pro grams. Most child-wel fare and fos ter care ben e fits are also elim i nated;

— *Law En force ment:* Ser vice pro vid ers are re quired to re port sus pected

un doc u mented im mi grants. Law-en force ment agen cies must ver ify the res i dency sta tus of in di vid u als ar rested or sus pected of be ing in the United States il le gally. When legal res idency cannot be proved, the per son will be re ported to the United States Im mi gra tion and Nat u ral iza tion Ser vice.

With grace and con cern, the Church must ad dress the le gal, eco nomic, so cial, and hu man rights con di tions of peo ple who are legal or un doc u mented im mi grants, and it must op pose the in tro duc tion of leg is la tion by **Congress** or any state that would cause hu man suf fer ing and a de nial of such in di vid ual's rights as in ter preted through our bi bli cal un der stand ing of God's grace to all peo ples, but es pe cially to the so jour ner. Our faith, grounded in Christ and in the Wes ley an call to work for prophetic justice, calls us to fol low our So cial Prin ci ples and re spond in ap pro pri ate and di rect ways to pre vent harm to the so jour ner.

Je sus teaches us to show spe cial con cern for the poor and op pressed who come to our land seek ing sur vival and peace. We call upon United Meth od ists in di vid u als **and churches in the United States** and through gen eral boards and agen cies throughout The United Meth od ist Church to do the fol low ing:

1. Actively op pose anti-im mi grant legis la tive ac tion and sup port legis la tive ac tion that pro tects the poor and op pressed in their quest for sur vival and peace;

2. Urge strin gent po lic ing and pen al ties for coyotes (il le gal trans porters); and those **in di vid u als, busi nesses, or groups that fuel them and other ex plo iters of un doc u mented im mi grants,** since their ac tiv i ties may cause

im mi grants to suf fer se ri ous in jury or death;

3. Urge that hu mane and fair treat ment be ex tended to all im mi grants by busi ness and ag ri cul tural groups;

4. Ad vo cate hu man rights (po lit i cal, eco nomic, and civil) for all peo ple, in clud ing the stran gers who so jour n in our land;

5. Sup port com mu ni ties and con gre gations by prayer and ac tion where anti-im mi grant mea sures **are** may be im ple mented;

1. **Congregations, district, conferences, and ecumenical coalitions in sovereign nations and lesser political entities where the death penalty is currently practiced are called to take overt action to change the laws and social conditions which produce this violent act.**

2. **Persons and groups who take this moral issue into the public arena (such as addressing elected officials, vigils, letter-writing campaigns, paid advertising, and other responsible direct action) will be supported by the church.**

3. **The General Boards of Global Ministries and Church and Society and their affiliates throughout the denomination and ecumenical partnerships are called to develop strategies of education and political action to overcome the evil of capital punishment.**

4. **The global scope of the protest summons the people of the church to seriously oppose this abhorrent practice, and for United Methodist persons to incorporate this protest into their personal social conscience.**

5. **Commend the people who have provided moral judgement, prophetic insight, pastoral care for those who suffer from this practice, and have borne the pain of hostility and in difference to this advocacy.**

**CHILDCARE AND THE CHURCH:
 A NEW RESOLUTION**

d. Personnel: As congregations seek to support childcare programs, salary, benefits, and support of the staff of these programs should be of concern and subject to review and discussion to insure the best for the children and families involved. Congregations must assure that children are served through the best care givers. Congregations have a responsibility to advocate for higher pay and benefits for childcare workers. These professional care givers should maintain excellence and integrity in the important job they do, and they should be appropriately compensated for it.

With increased concern around issues of child abuse, congregations need to assure that all childcare providers have been adequately screened *for child abuse and neglect in accordance with laws of local jurisdiction, especially in the area of sexual misconduct*. Appropriate screening protects the children, the childcare providers, and the congregation. The personnel issue also includes a concern for the education and training of childcare workers. A yearly plan for continuing education should be part of the congregation's support for childcare providers. Many childcare providers have extensive training and education in the field. They are good sources for training of those who work with children in other areas of the church, including childcare workers for Sunday services, Sunday school teachers, and vacation Bible school teachers. For those who are hired without proper training and education, the congregations should sponsor and encourage attendance at continuing education events.
